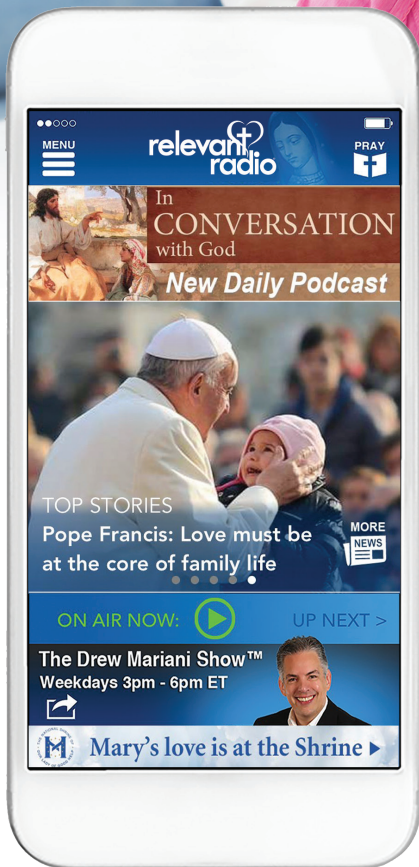

About Our Honoree . . .

Carly Fiorina shattered the glass ceiling at AT&T in the early '90s when she became the company's first female officer. In 1999, she was named CEO of Hewlett-Packard, the first woman to lead a FORTUNE 20 company. "Carly Fiorina didn't just break the glass ceiling," *Fortune Magazine* said at the time, "she obliterated it." During the 2015 Republican presidential debates, Mrs. Fiorina broke through another kind of barrier, becoming the first major politician—female or male—to speak with fearless no-holds-barred candor of the broken bodies of aborted infants seen on videotapes made secretly at Planned Parenthood clinics. When challenged by Chuck Todd on *Meet the Press* about her description of a baby who was still breathing after the procedure, she didn't back down: "That scene absolutely does exist," she told him, "and that voice saying what I said they were saying—'We're gonna keep it alive to harvest its brain'—exists as well." She had also taken on the controversial abortion issue in her 2009 bid to unseat California senator Barbara Boxer—who will be remembered for declaring that a baby attains rights "when you bring [him or her] home" from the hospital.



"Human potential," Mrs. Fiorina, has said, "is the only limitless resource we have in this world." In 2008, she joined Secretary of State Condoleezza Rice in founding the One Woman Initiative, and served as Global Board Chair when that organization later merged with Opportunity International. Over the past 15 years, Opportunity International has created 10 million jobs through \$46.8 billion in loans—the average loan being about \$150. She has also chaired Good360, a charity that has distributed more than \$8 billion in donated goods to more than 40,000 nonprofits. "What's true here at home is true in Congo, Tanzania, Romania, India, the Phillipines, Colombia, and Nicaragua," she says, "the poor aren't poor because they lack ambition or intellect, but because they lack opportunity, tools, and someone to take a chance on them. A job, an education—these things unlock potential and change lives."

About Our Speakers . . .

Rev. Gerald Murray is a priest of the New York Archdiocese and pastor of the Church of the Holy Family, also known as the “United Nations Parish.” A commentator on religious issues for television and radio outlets, including EWTN, Fox News, MSNBC, Relevant Radio, and Voice of America, Fr. Murray served in the US Naval Reserve Chaplain Corps from 1994 to 2005.

James McLaughlin is the Chairman of the Board of Directors of the Human Life Foundation. He is a Managing Director of Lincolnshire Management, Inc., a private equity firm headquartered in New York City. Prior to joining Lincolnshire in 2005, he was a partner with the global law firm Pillsbury Winthrop, practicing corporate law.

Dawn Eden Goldstein, the first woman to earn a canonical doctorate from the University of St. Mary of the Lake, is an assistant professor of dogmatic theology at Holy Apostles College and Seminary in Cromwell, Conn. Her books (under the pen name Dawn Eden) include *The Thrill of the Chaste* and *My Peace I Give You: Healing Sexual Wounds with the Help of the Saints*.

Larry Kudlow is CNBC’s Senior Contributor and the host of WABC Radio’s “The Larry Kudlow Show,” a weekly program syndicated by Cumulus Media. He is also a nationally syndicated columnist as well as a contributing editor for National Review Online. A former economic advisor to President Ronald Reagan, his latest book is *JFK and the Reagan Revolution*.

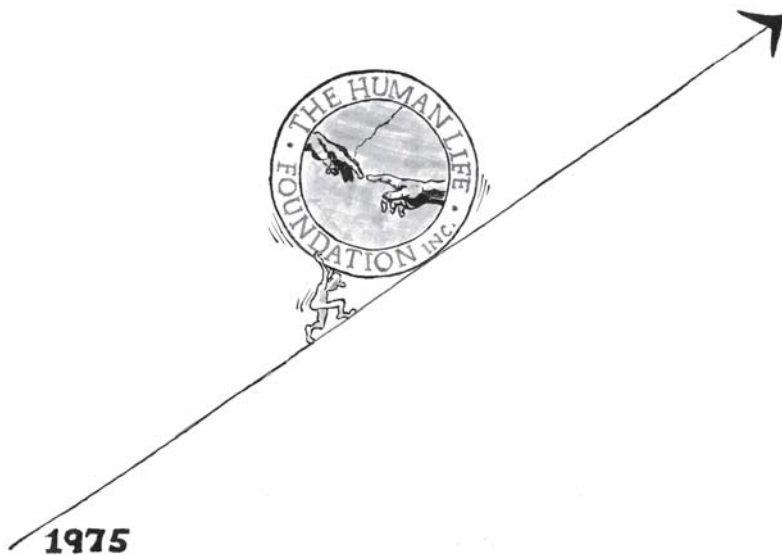
About the Foundation . . .

Founded in 1974, the Human Life Foundation, Inc. is an independent, not-for-profit, non-sectarian organization chartered specifically to promote—and to help provide—alternatives to abortion. The Foundation seeks to achieve its goals through educational and charitable means, and welcomes the support of all those who share its beliefs in the sacredness of every human life (however helpless or “unwanted”) and are willing to support the God-given rights of the unborn, as well as the aged, the infirm—all the living—whenever and wherever their right to life is challenged. All contributions to the Human Life Foundation are deductible from taxable income according to the Internal Revenue Code: Section 501 (c) (3). The Foundation, which is chartered in the State of New York, is not affiliated with any other organization or group.

Education: Since 1975, the Human Life Foundation has published the *Human Life Review*, a quarterly journal focusing on abortion and a variety of other life-and-death issues. In 42 years of continuous publishing, the *Review* has compiled perhaps the most extensive record that exists of the abortion debate since *Roe v. Wade*. The entire archive is accessible online at the foundation’s website, www.humanlifereview.com.

EXPECT: *The Human Life Review’s* initiative for students and young professionals, EXPECT sponsors events that bring together national pro-life leaders and provide valuable opportunities for young people to express their views and network with each other. Panel discussions, addressing abortion and other life-and-death issues from various perspectives, have been held at Columbia University and Fordham University; EXPECT has also participated in several college gatherings, most recently at Yale’s 2017 Vita et Veritas Conference.

Charitable Outreach: The Human Life Foundation, from its beginning, has helped to support crisis pregnancy centers around the country through a “baby saving” matching-grant program. Contributions to the Foundation may be earmarked for this alone.



Meet the Staff of the Human Life Review



Maria McFadden Maffucci is editor, since 1998, of the *Human Life Review*; she started as managing editor in 1990. Mrs. Maffucci was previously managing editor of the monthly journal *First Things* (1989-1990); and of the quarterly *This World* (1988-1989). Her articles and editorials have appeared in the *Human Life Review*, *First Things*, *National Review Online* and *National Review*, as well as in *The Silent Subject: Reflections on the Unborn in American Culture*, and *The Reach of Roe: Eugenics, Euthanasia and Other Assaults on the Dignity of Human Life*, edited by Anne Conlon. A Holy Cross graduate with a BA in philosophy, she is married to Robert E. Maffucci, and the mother of three children.

Anne Conlon has been **managing editor** of the *Human Life Review* since 1995, during which time she has edited several collections of essays from the *Review's* archives, most recently *The Reach of Roe: Eugenics, Euthanasia, and Other Assaults on the Dignity of Human Life* (2013). Before that she worked for 12 years as a bona fide Mad Woman, that is, as an advertising copywriter on Madison Avenue. She graduated from the University of Massachusetts (Amherst) in 1976 with a BA in English literature.



Christina Angelopoulos (nee McFadden), is the fifth child of J.P. and Faith McFadden, and began working full-time for the Human Life Foundation in 2003. She has since worked to expand the Foundation's **technology, operations efficiency, archive organization, and social media presence**. A graduate of Fordham University, Mrs. Angelopoulos lives in Westchester with her husband and twin girls, and also sings professionally in Manhattan.

Rose Flynn DeMaio, a graduate of New York University with a BS in Accounting, was employed with J.P. McFadden at *National Review* when he founded the Human Life Foundation. Believing in J.P.'s ability to bring intelligent information to the public, she became the Foundation's independent accountant. After her retirement from *National Review*, she became the Foundation's **Financial Director and Board Treasurer**.



Ifeoma Anunkor is the **Human Life Foundation's McFadden Fellow and director of EXPECT**, the Foundation's initiative for reaching young professionals and college students. She plans forums for intellectual discussion and social engagement as well as researching and writing on pro-life laws and culture. 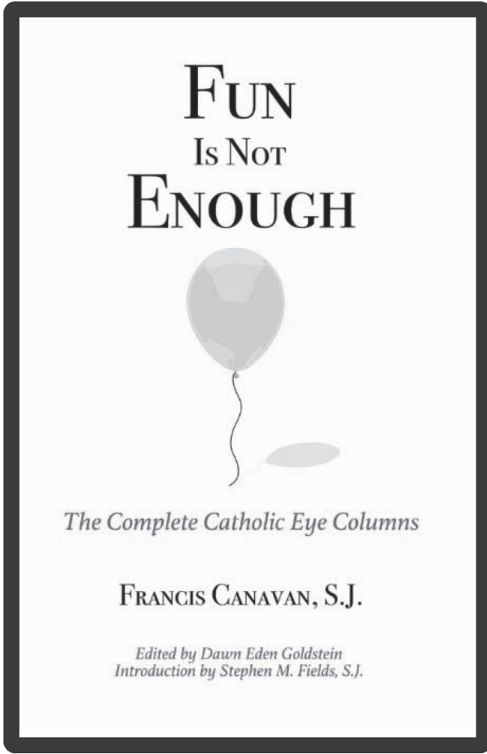
Our Founder . . .

James Patrick (J.P.) McFadden (1930-1998) was a long-time Associate Publisher of *National Review* magazine. In 1974, in response to the Supreme Court's infamous decision in *Roe v. Wade*, he founded the **Human Life Foundation**, which began publishing the quarterly journal *Human Life Review* in 1975. He died in 1998 after a five-year battle with cancer.
